


**International Labour and Environmental Standards [ILES]
application in Pakistan's Small & Medium Enterprises [SME's]**

ILES is European Union [EU] funded project and will be implemented through International Labour Organization [ILO] and World Wide Fund for Nature, Pakistan [WWF-Pakistan]. It is a six year project [January 2017 – December 2021], with the overall objective to “Support the economic integration of Pakistan into the global and regional economy by increasing exports and competitiveness through improved compliance with labour and environmental standards”. The labour and environmental components of ILES project will be executed by ILO and WWF-Pakistan respectively. WWF-Pakistan has engaged Cleaner Production Institute [CPI] as Consultants to initiate this project by contacting the targeted Textile and Leather sector SME's with the objective to “Implement Smart Environmental Management Practices [SEMPs], for Water and Energy Efficiency, Safe Use and Management of Hazardous Chemicals, and Pollution Mitigation”.

Project Focus: WWF-Pakistan through CPI will address Cleaner Production, Improved Resource Efficiency (including water and energy), and Reduced Pollution (in terms of air, noise and solid waste). ILO will address the Decent Work, Occupational Health and Safety [OH&S] practices and local labour laws application.
